Please return the warranty registration or register your warranty online within 90 days of the installation of your Oshkosh Designs product to activate your warranty.

This warranty is non-transferable and is exclusive to the original purchaser of the Oshkosh Designs product.

All Oshkosh Designs products must be installed within 30 days of product purchase or warranty will be voided.

# Warranty

It is the responsibility of the installer and/or property owner to inspect the product prior to installation. If, before installation, you discover any product that has a perceived defect, please contact your Oshkosh Designs dealer immediately to arrange for repairs or replacement product.

Oshkosh Designs accepts no responsibility for costs of products or labor when products with perceived defects have been installed nonetheless.

Damage caused by natural or man-made disasters – including, but not limited to leaking or broken plumbing, standing water, fire, excessive rainfall, hurricanes, tornadoes, flooding or other disasters – are not covered by the terms of this warranty.

Failure to properly maintain your field floor, decorative inlays or parquet will void all warranties.

### **Warranty Details**

No parquet flooring, decorative hardwood, or stone floor inlays are manufactured to higher quality standards than the parquet and decorative inlay offered by Oshkosh Designs. That singular fact alone allows us to offer the following warranties:

- Oshkosh Designs warrants its decorative inlay and parquet to be free from manufacturing defects in lamination, milling, and assembly. We warrant these products, to the original purchaser, for a period of one year after date of purchase. If the Oshkosh Designs product is installed using a non-recommended adhesive warranty is voided.
- Oshkosh Designs will (at our discretion) repair or replace any Oshkosh Designs
  decorative inlay or parquet that has experienced de-lamination between the
  product wear layer and substrate, if applicable, due to glue bond failure for one
  time only. Repair or replacement is limited to Oshkosh Designs product only.

Prior to installation, completion of the provided Oshkosh Designs pre-installation checklist is required for warranty to be applicable. Failure to complete checklist or meet the requirements outlined on the checklist will void warranty.

There are no implied warranties, including merchantability and fitness for a particular purpose, extending beyond the terms of this warranty, and except as set forth herein, there are no other warranties by Oshkosh Designs.

Except for the specific remedies set forth herein, Oshkosh Designs shall have no liability for any damages, incidental or consequential, resulting from the purchase, installation, or use of the Oshkosh Designs product. The terms of and remedies available under this limited warranty can only be modified or extended if expressly authorized, in writing, by Oshkosh Designs management.

### **Warranty Exclusions and Limitations**

It is critical that all installations are done in compliance with the procedures outlined in the Oshkosh Designs installation manuals. Failure to install in accordance with these instructions will void all warranties.

Oshkosh Designs does not warrant mounted (engineered) product that is less than 5/8" thick and greater than 30" in width or length.

#### **Natural Variations**

Oshkosh Designs uses a wide variety of the finest materials. Our products will vary in color, texture, and graining. The following natural characteristics are not to be construed as defects: mineral streaks, small knots, grain and color variations, sap pockets, flecking, fissures, texture, pitting or other natural material distinctions. Additionally, actual product appearance may vary slightly from product images shown in brochures, online galleries or other printed materials or websites.

Natural changes in color due to aging is expected and is not a defect. These variations in parquet and decorative inlay are natural occurrences due to species and age of wood or stone, plus exposure to UV lighting. Such variations contribute to the natural beauty and character of these materials.

We cannot warrant against natural variations, nor the differences between color, grain, and appearance of product samples, surrounding field floor, millwork, other wood products, and the color, grain and appearance of Oshkosh Designs products. Furthermore, this warranty does not cover color changes to any products that are the result of UV light and/or the natural aging process of the wood, glass, metal, or stone.

## **Temperature and Humidity factors**

Hardwood inlays are natural products and will expand and contract during heating and non-heating seasons, causing changes in joinery or the inlay products. These changes in joinery are not considered defects. To minimize these changes as much as possible, it is vital that reasonable humidity conditions (30 to 50 percent humidity at 60 to 80°F) are maintained consistently at all times. It is also important to allow time for proper acclimation of the product to the property climate conditions prior to installation. **No warranty coverage is provided for product that experiences glue bond failure, cupping, buckling, gapping or cracking due to inadequate, excessive or widely fluctuating humidity levels.**
